Accelerating Michigan's economic growth, one Israeli innovation at a time



Dear Partners and Supporters:

We are pleased to present the Michigan Israel Business Accelerator's (MIBA) annual report for 2023, which contains highlights of our organization's performance, as well as stories of impact from across the Michigan-Israel innovation ecosystems. This transformative year was marked by collaboration, growth, resilience, and a prevailing sense of hope, making it the most impactful year in the MIBA's six-year history.

Our commitment to uniting a growing community of Israeli and Michigan innovators addressing our state's challenges remained at the forefront of our work. Throughout the year, we facilitated visits for 37 leaders to Israel, hosted 15 Israeli companies in Michigan, welcomed 86 Michigan leaders to experience Israeli innovations, and connected 1,218 Israeli and Michigan companies, generating over \$7 million in economic activity for Michigan.

The standout moment was our launch of The Elevator in June, the first coworking space in the U.S. designed to help Israeli startups and companies scale. Subsequently, six Israeli tech companies partnered with The Elevator to scale in Michigan, transforming our community space into a bustling hub that welcomed over 350 individuals through coworking and events by the year's end. The surging demand from Israeli innovators led us to expand our teams in both Israel and Michigan.

In response to the events of October 7th, the MIBA pivoted to maximize our impact. We coordinated efforts to align Israel's needs with Michigan businesses' support, collaborating on military and infrastructure requirements. We offered our community of supporters webinar updates, incorporating insights into Israel's business landscape from government leadership. With the MIBA's annual Taste of

Two Nations event postponed, our supporters redirected contributions totaling \$15,000 to Magen David Adom, Israel's national emergency medical, disaster, ambulance and blood bank service. Continuing in the Israeli spirit, we persevered with business activities by hosting Israeli companies in Michigan, actively contributing to ongoing efforts to support Israel's economy.

Reflecting on six years of fostering connections between Michigan and Israeli businesses for economic development, we recognize that our impact would not have been achieved without our valuable partnerships. Thank you to our forward-thinking ecosystem partners for collaborating with us to move groundbreaking innovations and economic development forward. And a special thank you to our Board of Directors and supporters for believing in our mission.

As extraordinary as this past year has been, we are confident that 2024 will present even more news to celebrate as Michigan-Israel partnerships continue to advance innovation and economic prosperity across both regions.

The Michigan Israel Business Accelerator (MIBA) is a nonprofit and nongovernmental economic development organization committed to fostering partnerships between Israeli and Michigan businesses. The MIBA's purpose is to create economic opportunities and drive job creation through collaboration and innovation.

Established in 2017, the MIBA emerged as a prominent connector within Michigan's economic development ecosystem, with a specialization in facilitating trade and partnerships through delegations and programming.

In 2023, the MIBA broadened its reach and established The Elevator, the first-of-its-kind landing zone in the U.S. exclusively for Israeli startups and companies. With a dedicated focus on fostering connections between Israeli businesses and Michigan enterprises, The Elevator aims to accelerate Israeli business expansions in Michigan.





Israeli Companies Choosing Michigan

As an economic development organization dedicated to fostering partnerships between Michigan and Israel, we take pride in every win, recognizing that successful collaborations are the result of collective efforts from stakeholders across the innovation ecosystem.

A Case in Point: Our engagement with Electreon began in 2020 when we learned about their in-road charging for electric vehicles. Fast forward to 2022, our mobility delegation facilitated the visit of Michigan's mobility leaders to Israel, where they experienced Electreon's groundbreaking inductive charging system firsthand. Today, the combined efforts of many key partners within Michigan's innovation ecosystem have been instrumental in making this innovative Israeli technology a reality in Michigan, the first of its kind in the United States!

Visionary Israeli Companies Redefining Possibilities



GuardKnox is an AutoTech company developing products that address the key challenges in the new generation of vehicle architecture and that enable the software-defined vehicle.

In 2020, this Israeli firm identified Michigan as the ideal place to open the headquarters for its U.S. wholly owned subsidiary, knowing that the major decision-makers in the automotive market are found here in the Detroit area. After finding success on the sales front, GuardKnox doubled-down on the Detroit area, expanding their team by tapping into Michigan's talent base, adding an engineering team to develop their solutions here as well.

GuardKnox is a prime example of how an Israeli company found a second home in Michigan by starting small and growing over time.

"Michigan has proven to have everything the GuardKnox team needs for success. Any Israeli company that aspires to succeed in the U.S. should consider reaching out to the MIBA team sooner rather than later," said Moshe Shlisel, CEO & Co Founder, GuardKnox Cyber Technologies.



The Elevator

The only landing zone in the U.S. dedicated to supporting the growth of Israeli companies, offering:



Access to Michigan organizations to scale technologies.



Free dedicated office space and a U.S. address to facilitate business operations.



Deliberate, relevant B2B and B2G meetings that connect communities to drive business opportunities.

Matchmaking

At the heart of the MIBA is our curated B2B and B2G matchmaking, where we connect Israeli and Michigan companies based on compatibility and shared synergies.

Trade Delegations

Since 2018, the MIBA has brought over 150 Michigan delegates to Israel. Beyond planning deliberate B2B and B2G meetings, the MIBA prioritizes immersing delegates in the culture, history, and geopolitics of Israel, enhancing understanding of the innovation ecosystem.

Delegation Sponsorship

In late 2023, the MIBA initiated a Delegation Sponsorship Program with the William Davidson Foundation to boost representation of diverse companies in our Israel delegations. This sponsorship covers registration and partial airfare for revenue-generating startups in Southeast Michigan aligned with the delegation sector. A sponsorship was granted to a Women in Mobility delegate, though their trip slated for late October was postponed.



The Launch of The Elevator

On June 9th, 2023, "The Elevator," the first and only landing zone in the U.S. dedicated to aiding Israeli startups and companies scale, was officially introduced by Mark Davidoff (Founding Board Member of the MIBA), Matt Elliott (Board Chair and President of Bank of America Michigan), and Quentin Messer, Jr. (President and CEO of the Michigan Economic Development Corporation). This launch signifies a substantial step toward the MIBA's vision of positioning Michigan as the leading partner for Israeli innovation in the U.S.

Our community space has evolved into a bustling hub, welcoming 361 individuals through coworking and events by the year's end. The surging demand from Israeli innovators led us to double our teams in Israel and Michigan.





Leveraging The Elevator

Fullpath is a leading automotive customer data and experience platform, having built a marketing automation solution for auto dealerships that automates and optimizes customer touch points throughout the life of a customer.

Fullpath became one of the MIBA's charter members of The Elevator, signing on as a partner when it opened in June. This gave Fullpath a place for their two Michigan-based employees to meet regularly in person for the first time. The resulting improvement in team dynamics and productivity spurred Fullpath to institute two changes: 1) they named Detroit one of their worldwide hubs and 2) they declared that new hires going forward must be hired in one of their hubs.

As a result of their Elevator experience, Fullpath has already added one additional team member in the Detroit area and opens the way for more Michigan jobs to be created.
